Zhejiang Energy Group Co Ltd owns 60% of the equity interests in ZHEJIANG ENERGY INTERNATIONAL LIMITED, and Zheneng Capital Holdings Co., Ltd will own 40% of the equity interests in ZHEJIANG ENERGY INTERNATIONAL LIMITED. Zheneng Capital Holdings Co., Ltd is 100% controlled by Zhejiang Energy Group Co Ltd . Zhejiang Energy Group Co Ltd is 100% controlled by State-owned Assets Supervision and Administration Commission of the People's Government of Zhejiang Province (浙江省人民政府国有资产监督管理委员会).
